## 2 Processing Framework

## 2.1 Data categories

In connection with the information event "Career goal UAS professorship", we process personal data that we have collected directly from you. Relevant personal data in connection with participation in the event are:

- Master data (e.g. name, address)
- Contact data (e.g. e-mail address, telephone number)
- Content data (e.g. text entries, photographs, videos)
- Meta and communication data (e.g. device information, IP addresses)
- User name/pseudonym

#### Optional:

- Location data
- Audio data

# 2.2 Purposes and legal basis of the processed data

We process your data in connection with your registration for our information event "Career goal UAS professorship". This registration can be done either by email or via the SoSci Survey service we use.

We further process your data for the purpose of conducting the information event. We conduct our information events in hybrid form. It is possible to participate both on-site BigBlueButton Inc.



a) Legal basis for employees at the university.

We process your data for the purpose of registration for the information event on the basis of Art. 6 para. 1 lit. e DSGVO, Art. 88 DSGVO in conjunction with §§12 LHG, §15 LDSG and §§ 83 LBG in conjunction with §§ 45, 56, 44 LHG; on the basis of Art. 6 para. 1 lit. a) DSGVO. Processing on the legal basis of Art. 6 lit.a DSGVO takes place in particular if the use of the online tool is initiated by you or if you voluntarily provide us with data that is not mandatory for the implementation of the online service (so-called optional information).

b) Legal basis for external participants

We process your data on the basis of Art. 6 (1) a) DSGVO if you voluntarily provide us with data that is not absolutely necessary for the implementation of the online service (so-called optional information).

### 2.3 Recipients of the data

#### 2.3.1 Within the EU

We also use the external service SocSci Survey GmbH to collect personal data. Our service providers act within the framework of order processing in accordance with Art. 28 DSGVO. Your data is therefore subject to the same security standards there as it is with us. In other cases, the recipients may only use the data for the purposes for which it was transmitted to them.

#### 2.3.2 Outside the EU

A data transfer to countries outside the European Union (EU) or the European Economic Area (EEA), so-called third countries, takes place. This only takes place in the presence of suitable guarantees within the meaning of Art. 44 et seq. DSGVO.

#### 2.3.3 Overview of recipients

The following recipients receive your data within the scope of the data processing described here:

Recipient: Microsoft Corporation, One Microsoft Way, Redmond, WA 98052-6399, USA

Third country transfer: There is no adequacy decision for the transfer. The transfer is based on Art. 46 DSGVO.

Services used are provided by Microsoft, a US provider. Processing of personal data thus also takes place in a third country. We have concluded an order processing agreement with the

provider of the services, which meets the requirements of Art. 28 DSGVO.

The transfer of the data to a third country only takes place when the special requirements of Art. 44 et seq. DSGVO are fulfilled. The present transfer of data to the USA is based on the standard data protection clauses and the amended contractual terms following the Schrems II ruling. Specifically, the following provisions were made in the new contractual clauses by

Microsoft:

• the right to compensation for the data subject whose data has been unlawfully processed and who has suffered material or immaterial damage as a result;

• informing the data subject if Microsoft has been legally required by a government order to

turn over data to U.S. security authorities;



• Microsoft's obligation to seek legal recourse and apply to the U.S. courts to challenge the government order to turn over the data.

Third country transfer: An adequacy decision has been obtained for the transfer.

Third country transfer: A third country transfer does not take place.

#### 2.4 Automated individual case decisions

We do not use any purely automated decision-making processes pursuant to Art. 22 DSGVO.

### 2.5 Storing Duration

After the information event has been held or after revocation of your consent, your data will be deleted after 6 weeks at the latest, unless there are legal retention obligations.

# 3 Your rights

Under certain conditions, you can assert your data protection rights against us. Your requests regarding the exercise of your rights should, if possible, be addressed in writing or by e-mail to the address given above or directly in writing or by e-mail to our data protection officer.

- You have the right to receive **information** from us about your data stored by us according to the rules of Art. 15 DSGVO (if necessary with restrictions according to § 34 BDSG).
- Upon your request, we will correct the data stored about you in accordance with Art. 16 DSGVO if it is inaccurate
  or incorrect.
- If you wish, we will **delete** your data in accordance with the principles of Art. 17 DSGVO, provided that other statutory regulations (e.g. statutory retention obligations or the restrictions under Section 35 BDSG) or an overriding interest on our part (e.g. for the defense of our rights and claims) do not prevent this.
- Taking into account the requirements of Art. 18 GDPR, you may request us to **restrict** the processing of your data.
- Furthermore, you may **object** to the processing of your data in accordance with Art. 21 DSGVO, on the basis of
  which we will terminate the processing of your data. This right of objection only applies in the event of very special
  circumstances of your personal situation, whereby rights of our company may oppose your right to object.
- You also have the right to receive your data under the conditions of Art. 20 DSGVO in a structured, common and machine-readable format or to **transfer** it to a third party.
- In addition, you have the right to **revoke** your consent to the processing of personal data at any time with effect for the future.



- Furthermore, you have the **right to lodge a complaint** with a data protection supervisory authority (Art. 77 DSGVO). However, we recommend that you always first address a complaint to our data protection officer.
